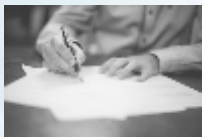

## KEY INITIATIVES

Organized an international study tour for women CAs, fostering global professional opportunities. Arranged residential refresher courses, allowing women to focus on their personal and professional growth, and grand-level women conferences to inspire and connect. Additionally, initiated a portal for 'Second Inning' women returning after a career break and bridged the gap between firms and women members. and led numerous motivational programs to empower women in the profession."

## **Easy Connect with ICAI: A Direct Communication Platform for Members and Students**
